Membership in the FCCM is available in several categories. ### Ordinary Member

- Journalist.** Working print, broadcast, photographers or photojournalist based in Malaysia but principally employed by press or media organisations headquartered outside of Malaysia and for which the main audience is abroad.

### Associate Member

- Non-journalist.** Executives who work for a foreign news organisation.
- Former journalist.** Former print, broadcast, photographer or photojournalist based in Malaysia and previously employed by a foreign news organisation.
- Local NGO.** Working staff of an NGO headquartered in Malaysia and active here or in neighbouring countries.
- International NGO.** Up to two applicants joining (or renewing) at the same time from an NGO headquartered outside Malaysia and active in more than one country or region.
- Corporate and Diplomatic.** Up to three applicants joining (or renewing) at the same time from local or international corporation, embassy or diplomatic mission; memberships are transferable within the same organisation.
- Local Journalist.** Working print, broadcast, photographers or photojournalist employed by press or media organisations headquartered in Malaysia, and for which the main audience is domestic.
- Academia.** Teaching staff at an accredited college, technical school or university.
- Government.** Up to two applicants joining (or renewing) at the same time from Malaysian government ministry or agency; memberships are transferable within the same organisation.
- Public.** Non-journalists from the public or private sectors with an interest in the press and in public and current affairs. Applicants must be nominated by a correspondent Member and seconded by another Member in good standing.

*Registration fees and initial dues are payable when an application for membership is submitted; no refund is available unless your application is rejected by the FCCM. There is a one-time registration fee of MYR100 for all categories.*
